We had a fine turnout for the community meeting in March--close to 200 people. Support for our incorporation efforts was over 95%! Good discussion and lots of questions were answered.



#### FMCA March Highlights

The Welcome to Fort Morgan District 25 sign is now installed on the north side of Fort Morgan Road, just west of the Gulf Shores city boundary. It was installed just in time for the Town Hall meeting of March 5<sup>th</sup>. Thanks to the committee, headed by Carol Kittrell, and to the installation crew Ken and Emily Steiner and Paul Barefield. It is a handsome welcome to our community.

The Community Town Hall meeting to discuss incorporation of District 25 drew an estimated 200 property and business owners and peninsula residents to Fire Station #2 on the afternoon of March 5<sup>th</sup>. President Paul Barefield made a balanced presentation of the pros and cons of incorporation. The majority of those attending were in favor of incorporation and several wanted more information before deciding.



A letter will be sent to Alabama state legislators asking for their support of the Fort Morgan incorporation bill. The letter will include reference to the historical and environmental importance of Fort Morgan and appreciation of their positive vote to allow only the voters of an affected county or political subdivision to vote on the amendment.

## Incorporation of Fort Morgan District 25 ~ Bill is in the Alabama House!

The incorporation bill was introduced in the House by Rep. Steve McMillan Monday, March 21<sup>st</sup> and received its first reading. It was then referred to the Baldwin County Legislative Committee. **IF YOU ARE AN ALABAMA RESIDENT, PLEASE CONTACT YOUR ALABAMA LEGISLATIVE REPRESENTATIVE AND SENATOR AND REQUEST THEIR SUPPORT FOR THIS BILL.**

## Turtle Tracks 2016~~~~~Volunteers Needed!!

Fort Morgan Share the Beach team is urgently seeking volunteers for the 2016 sea turtle nesting season starting May 1. Bon Secour National Wildlife Refuge has lost some of its funding and will no longer cover non-Refuge areas with its UTVs. This leaves 8 miles of beach to be covered, an especially difficult task for early morning nest searching from May 1 through August 31. When the situation became known, members of the community rallied around the Fort Morgan Turtle Team. Many individuals and several businesses showed eagerness to donate for an all-terrain vehicle or to sponsor fund-raising events.

NEEDED NOW: volunteers willing and able to walk approximately 1 mile of beach in the early mornings to locate sea turtle tracks and nests. Team leaders will try their best to make it possible for you to pick the days you want to walk and the section of beach that you prefer. ## Fort Morgan Volunteer Fire Department .....Chief Glenn Stevens

During February, your Fire Department responded to 25 calls: 12 medical, 12 false alarms, and 1 brush fire. March started off with a bang with 4 brush fires within a 24-hour period; all started from downed power lines due to high winds. One fire in the 4800 block of Highway 180 spread to both sides of the highway due to high winds. It took three hours and the help of Gulf Shores Fire Rescue to control the fire.

Spring breakers have invaded our area, and we expect to stay busy for the duration. Our young firefighters have stepped it up to help us with the large call volume, and some firefighters have volunteered to stay overnight at the Station for a faster response time.

The Ladies Auxiliary's spaghetti dinner fund-raiser was very successful. The new tee shirts were a big hit. The money will be used to obtain proper equipment and training that can improve our ISO rating, which can lead to lower homeowners' insurance premiums. Our goal is to provide the best possible fire, medical, and rescue services to our community.

We're still hoping to see a few more residents join us at our training meetings on the first and third Mondays every month. Also, if you have any ideas or suggestions that you would like the Fire Department to consider, join us at our Board Meetings on the second Tuesday every month at Station 1 at 5:30 p.m.

## Fort Morgan State Historic Site

The Fort is still dealing with no main restrooms due to the collapse of the restroom septic system. If all goes as planned the restrooms may be back in operation by the start of the summer season. We are coping with porta-johns.



The Alabama Historical Commission has arranged to have radio spots and bill boards advertising the fort this spring. The bill boards will be located on 1-65 and 1-10.

Mike Bailey presented a program for 43 US Army Corps of Engineer officers and NCOs of the South Atlantic Division who were attending the Professional Development Conference in Mobile.

The spring looks to be very busy with a number of school groups booking tours through May. Some of these groups will have as many as 150 students.

During March 7-18 an Archaeological crew from the University of South Alabama conducted an archaeological dig around the Fort Morgan Ferry parking lot in preparation for installation of new lighting.

## Construction Proceeds on New Gulf State Park Lodge and Conference Center

Following a federal judge's decision that use of BP oil spill funds to construct the lodge is prohibited, Governor Bentley announced that construction will proceed as planned with funding identified from "other sources." The original lodge was destroyed by Hurricane Ivan in 2004, preceding the oil spill by six years. The State had planned to use \$58 million of the BP settlement to build the hotel and conference center, with an additional \$17 million to be spent on park improvements. Building of the lodge and center was lumped with park improvements into the "Gulf State Park Improvements" project. The Gulf Restoration Network (GRN), a non-profit environmental organization, filed suit and prevailed at the federal level on the basis that use of BP funds was improper.

SPRING BREAK Message from Sgt. Nathan Lusk, BCSO:

As I'm sure most of you know, Spring Break is upon us. The next couple of weeks will bring an influx of juveniles, young adults, and adults to the area. There is always a rise in crime when the number of people in a small geographic area increases. Please keep in mind to lock your valuables up, document serial numbers on serialized items and report suspicious activity. We recommend safeguarding your properties at all times and remind you and your homeowners association that lights, cameras and alarms help deter most property crimes. Cameras add valuable evidence to cases and we recommend cameras and DVRs with a minimum of 1080HD resolution and enough memory to sufficiently lap the time between checking your investments.

In a response to the likelihood of crime in the area, the Baldwin County Sheriff's Office has increased patrols and the number of Deputies available for the area. So far a large number of arrests have been made stemming from alcohol and drug violations. We will continue to maintain this added presence throughout the Spring Break Season.

### DISTRACTED DRIVING—AND WALKING?

In 2014, 3,179 deaths and 424,000 injuries were caused in the US by distracted driving, including driving while using cell phones, according to a study conducted by the National Highway Traffic Safety Administration (NHTSA). Hands-free devices are culprits in many cases since they lull drivers into thinking they can handle highway hazards safely. Other possible causes: eating, drinking, talking to a passenger, and adjusting music or other devices. Pedestrian deaths were up 10% in 2015 over 2014, and up 20% in the six-year period since 2009. More than 9 of 10 adults owned a cell phone as of January 2014.

**From the By-laws Adopted April 11, 2005**

**ARTICLE III – MEMBERSHIP**

- Section 1 Regular (voting) Membership in this association shall be open only to property owners and/or residents in the unincorporated area west of mile 14.7 of the Fort Morgan peninsula.
- Section 2 Associate (non-voting) Membership shall be open to residents of areas outside the Fort Morgan Peninsula whose interests coincide with those of the Association including the preservation of the environment and quality of life of the Fort Morgan peninsula.
- Section 3 Membership application shall be made by completion of a form provided by the Association and payment of the required dues. Dues for the following year shall be determined at the October general meeting and shall be for the following calendar year January 1st through December 31<sup>st</sup>.
- Section 4 Payment of Regular (voting) Membership dues entitles a member household to one (1) vote. A member household is comprised of Association members living at one physical address. Past year member households paying dues after January 31st and new members joining the Association will have no voting rights until thirty (30) days after payment of dues.
- Section 5 Payment of Associate (non-voting) Membership dues entitles the member to attend all member meetings and receive the monthly newsletter.
