PRESIDENT'S MESSAGE


Hi, Folks,

Your Fire Department responded to 28 emergency calls in August:

We recently took delivery of our new fire engine and are currently stocking the truck with equipment and supplies. The \$250,000 truck will need approximately \$40,000 in equipment in order to put the truck in service.

The Ladies Auxiliary will be holding their annual **fish fry fund-raiser on Saturday, October 8, from 11:00 a.m. to 2:00 p.m. at Fire Station #1**. The \$8 plates will include fresh fried fish, cole slaw, baked beans, hush puppies, and a drink. The ladies will be selling raffle tickets, cookbooks, and tee shirts, along with their world famous bake sale. Any baked goods donated to the sale would be greatly appreciated.



Recently, the Fire Department has received multiple complaints about seeing our ATVs riding in the sand dunes early in the morning and late in the afternoon. These ARE NOT OUR VEHICLES. Our ATVs are bright red with flashing red lights with fire department lettering and logos. Our ATVs are only allowed on the beach for emergencies and public assistance, such as the beach cleanup and advising beach-goers of a high risk of rip currents. We also set up on the beach with our ATVs and jet ski on holidays, such as the 4th of July.

Our recruitment drive continues. Come join us at our training meetings held on the 1st and 3rd Mondays each month at 6:30 p.m. at Fire Station #1.

History of the FMVFD Auxiliary.....Thelma Strong & Kay Stevens

After nudging by Ken Steiner, Thelma Strong and Wilhelmena Ryan called the ladies of Fort Morgan and we met. The Fort Morgan VFD Auxiliary was born January of 1992 with over 30 members. It was voted that we meet every 4th Thursday of the month with Wilhelmena Ryan as President, Hazel Nelson as Vice President, Mildred Hanson as Treasurer, and Thelma Strong as Secretary. Our purpose was to raise money to assist the Fire Department with their needs. Dues were \$2.00 per month as needed. That lasted only two or three months as we began to raise money with our events. Our first event was a spaghetti dinner and bake sale held March 7, 1992. We made a proud total of \$818.50

less expenses of \$228.50. We held our first Fish Fry May 16, 1992. The Firemen caught the fish for us so our profit was much better, a whopping \$954.75. So began the Auxiliary which we proudly work and support today.

The Fort Morgan Volunteer Fire Department Ladies' Auxiliary is still the fund-raising arm of the Department. Today, with the Department receiving significant tax money and generous donations from both the condos and homeowners, the funds raised are going into a fund for firefighters in need. Specific donations have gone to help a firefighter paralyzed in an accident, another with financial assistance after the loss of a job, and another to help with the funeral expenses of a firefighter.

The Ladies' Auxiliary now holds a spaghetti dinner in the Spring and a fish fry in the Fall. We meet in February and August or September to plan the events. In December, we get together for a salad and dessert luncheon just for fun.

Turtle Tracks 2016~~~~~Fort Morgan Nests = 95!

Sad news. We lost quite a few nests to storm tides caused by Hermione (the one that made landfall in southwest Florida) on September 1st. Excavations on several nests so far show over 300 dead hatchlings apparently fully developed and probably ready to hatch. We still have three nests approaching day 75 but not showing any signs of hatching. We also have several that will reach day 55 soon that we don't hold much hope for due to inundation from the storm. We do have two nests left where we have heard sounds that we are hopeful will produce some babies. According to Fish & Wildlife protocol, nests have to be at least at day 60 for help when there is danger of storm surge inundating the nest. In late summer most of our nests hatch before day 60. This year we have had 12 nests hatch before day 55, 43 before day 60.

Loss of Member ~ Margaret Solberger

Mrs. Solberger was a long-term member of the civic association.

Margaret Solberger was born in McKinney, Texas, on July 3, 1920, and died on August 21, 2016, in Spanish Fort. Her parents were the Rev. John Lorraine Oldham and Billie Jane Watkins Oldham. She grew up in Martinsburg, West Virginia and Jacksonville, Florida. She was a graduate of Florida State College for Women in 1942. She married Sam Solberger, Jr. in 1942 and lived many places before settling in Slidell, Louisiana in 1948. She taught English in Slidell and Mobile.

In 1962 Margaret and her family moved to Mobile where she lived until 2004 when she moved to Westminster Village in Spanish Fort. After her husband died, she returned to FSU for a Masters in Social Work in 1970. She then worked for the Alabama Department of Human Resources until retirement in 1985.

She was very active in several Episcopal churches throughout her life as well as the National Association of Social Workers and the League of Women Voters in Mobile and Baldwin Counties. She served in the Kairos prison ministry and on mission trips to Guatemala. Margaret is survived by two of her three children, five grandchildren, and one great-grandson.

MONARCH WALKS**

Have you ever wanted to learn more about the magnificent migration of the monarch butterfly and their fascinating life cycle? Come join Refuge volunteer Homer Singleton as he leads participants along the Gator Lake Trail searching for this beautiful butterfly. During the walk Homer will introduce you to the butterflies that pass through this area, their habitats and their life cycles. Participants will also be asked to help catch monarch butterflies so that they can receive tags that will allow scientists to track their migration.

The walks will start at Gator Lake trailhead located off Mobile Street. Walks typically last from 2.5-3 hours and participants should come prepared to walk over 2 miles, in soft sand, with minimal shade. Water and bug spray are highly suggested. **The walks will be limited to 12 participants; please make reservations by calling 251-540-7720.**

The monarch walks will be held at 9:00am, Wednesdays and Fridays, on the following dates: October 19, 21, 26, 28 & November: 2, 4, 9.
