### PRESIDENT'S MESSAGE

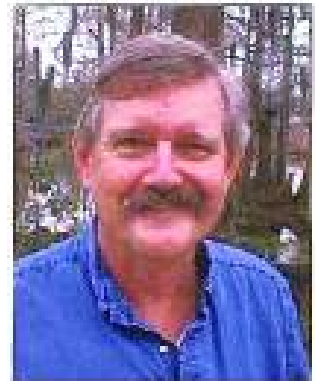
Hi, Folks,

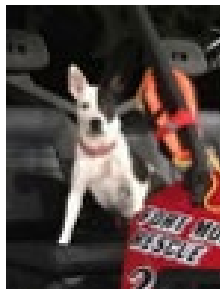

## Fort Morgan Planning & Zoning Advisory Committee

*The Fort Morgan Planning and Zoning Advisory Committee will post on our website [[www.fortmorgancivic.org](http://www.fortmorgancivic.org)] re-zoning and variance request notices received from the county commission. We also will send a special email to all on the association's email list of the posting and the time and place of our FMCA committee meeting. In most cases these notices are received about 10 days before the county Planning and Zoning Commission meeting.*

*Notice of the request is posted on the property involved and mailed to adjacent landowners. This is our attempt to let additional property owners, not adjacent, who will be affected by the request, express their concerns to our local committee before it submits a recommendation.*

*Any of our members who receive the Fort Morgan NEWS by U.S. Postal Service and wish to receive these notices will have to furnish us with an email address. The NEWS will then also be sent to that email address. To make the change, notify Chan West at [granchan@earthlink.net](mailto:granchan@earthlink.net)*

The committee met December 16<sup>th</sup> to consider a request to re-zone the Ewing property from B-2 to B-4 in order to accommodate a drive thru BBQ restaurant, adjacent boat/trailer storage and RV parking/storage.

B-4 zoning is a "major commercial district," intended for businesses needing access to major arterial roadways. This zoning designation also accommodates businesses which, because of their intensity, may have negative impacts on adjoining properties due to late hours of operation, noise, and/or light.

Adjoining property owners present at the meeting voiced concerns about potential noise and light distractions, as well as potential traffic issues—particularly during a hurricane evacuation. The committee also noted that District 25 has no area zoned B-4 presently.

Following consideration of the facts and ensuing discussion with adjoining property owners, the committee voted to recommend that the county commission deny the request to re-zone subject property.

## Fort Morgan History & Folklore

The following story is reprinted with permission of Harriet Outlaw. She commented that this is a folklore story based on tales people have told her. Her stories have their roots in oral tradition.

### OH, LEANDER, COME BACK TO ME

This story may not be found in history textbooks used in schools, but is one every child should hear, for not only is it entertaining, it could save a life.

The saga of Hernando DeSoto's exploration of the south is found in virtually every resource on early Alabama history. Children learn of his meeting with Chief Tuscaloosa, the Battle of Mauvilla and his burial in the Mississippi River.

However, there is much more to the story – some details that have come down through the ages without primary sources to back them up. Those stories can't be proven but they can't be disproved either. And they sure do make sense!

When DeSoto began his journey in Florida, he sent his ships back to Cuba with instructions to meet him later at the next big river to the west, which is the mouth of Mobile Bay. When the ships arrived at Gulf Shores, Hernando's beautiful wife Isabella was aboard. She is credited with planting the first fig trees and Nerium bushes in the New World. The Nerium shrubs were her favorite, and she walked by them every day calling for her husband using her pet name for him, Leander. As she cried, "Oh, Leander, come back to me," her tears watered the plants and the name Oleander came to be. Soldiers brought Isabella news of the Battle of Mauvilla and carried orders for the ships to meet DeSoto at the next large delta, the mouth of the Mississippi River. As Isabella sailed away from the Alabama shores, she could see the Oleander blooms and knew she was leaving behind hopes of seeing her husband alive again, and in her sorrow placed a deadly curse on the plants.

Oleander shrubs still thrive throughout the southern United States. They do well in sandy soil, bear long hot spells without water and are tolerant of mild freezes. They can grow to almost 20 feet high and from April to November are filled with fragrant pink, white and red blooms. However, their beauty hides a dreadful secret. Oleanders are among the most poisonous plants in the world. Gardeners must be extra careful with the clipping of the bushes as their sweet odor is especially attractive to horses and other livestock. When I was a

child, my father always warned me to never get near the smoke of burning oleander branches as it could cause blindness.

Many people have told me the story of the girl scout troop which was on a camping trip. The leader showed the girls how to cut branches of a nearby bush and shave the leaves away, making perfect skewers for roasting hot dogs over the campfire. The next morning, the entire group was found unconscious and most died. The Oleander sticks left around the campsite told the story.

So I hope the reader will share the story of the Oleander bush with someone. You may save a life.

Note: This story is among some of the fascinating “historical accounts” recorded by Hatchett Chandler who is credited with saving Fort Morgan from ruin. He was quite an interesting character, and his charming personality comes through in his book *Little Gems from Fort Morgan*. Mr. Chandler is one of those people I label Folk Characters, those real people whose true stories are better than any fiction. Baldwin County boasts quite a few of those and I will soon write a series of columns dedicated to their stories, which just maybe have been enhanced just a little through the years. Hatchett will be among the first.

**From the By-laws Adopted April 11, 2005**

**ARTICLE III – MEMBERSHIP**

Section 1 Regular (voting) Membership in this association shall be open only to property owners and/or residents in the unincorporated area west of mile 14.7 of the Fort Morgan peninsula.

Section 2 Associate (non-voting) Membership shall be open to residents of areas outside the Fort Morgan Peninsula whose interests coincide with those of the Association including the preservation of the environment and quality of life of the Fort Morgan peninsula.

Section 3 Membership application shall be made by completion of a form provided by the Association and payment of the required dues. Dues for the following year shall be determined at the October general meeting and shall be for the following calendar year January 1st through December 31<sup>st</sup>.

Section 4 Payment of Regular (voting) Membership dues entitles a member household to one (1) vote. A member household is comprised of Association members living at one physical address. Past year member households paying dues after January 31st and new members joining the Association will have no voting rights until thirty (30) days after payment of dues.

Section 5 Payment of Associate (non-voting) Membership dues entitles the member to attend all member meetings and receive the monthly newsletter.
