October Meeting Speaker: New Flood Map!

Please make a special effort to attend the October 9th FMCA meeting to hear Michael Howell, Baldwin County Building Department, speak to members regarding the impact on Fort Morgan peninsula of the recently issued changes to the FEMA Flood Map. Meeting begins promptly at 6:30pm in Shell Banks Church Fellowship Hall.

Fort Morgan Volunteer Fire Department

Chief Glenn Stevens With all the activity in the tropics, the Fire Department started preparing the Stations for the likelihood of a storm. When winds are sustained at 45 mph or more, there will be no fire or ambulance response in our area. Also, keep in mind that in the event of a Category 1 or stronger storm, all areas west of the 5 mile marker will most likely be under water since the Bay and the Gulf usually merge during these events. Our nearest shelter will be at the Robertsdale Coliseum.

Our emergency responses for August lightened up a little as the Department responded to 31 emergency calls:

- · 13 medical
- · 5 beach emergencies (2 boaters in distress, 1 swimmer in distress, 1 stingray laceration, and 1 missing person)
- · 5 false alarms
- · 3 fires (1 illegal beach fire, 1 BBQ grease fire, 1 garbage truck fire)
- · 3 elevator entrapments
- · 1 assault
- · 1 public assist

Fort Morgan Planning & Zoning Advisory Committee.....Chan West, Chair

The committee met on September 6, 2017, to consider two requests for variances:

- V-170032: 8818 Dolphin Ln., Cabana Beach. The owner requested a variance on front setback to construct a carport/storage shed in front of his house. The lot falls off too steeply in the rear for construction there. The application was incomplete, so denial was recommended.
- V-170034: two adjacent lots, north side of Hwy. 180, about 0.2 mi. west of Beach Club entrance. A variance on the setback was requested in order to add a porch to planned residence. These lots are narrow, 113.5' to 135'. Committee recommended approval.

TA-17001. The committee also decided to update our request that District 25 be exempt from the proposed revision to the county zoning of HDR (High Density Residential) which would increase maximum density from six units per acre to twelve.

A semi-annual meeting of this committee is set for 9:00 am, Wednesday, October 18, 2017, at the fellowship hall of Shell Bank Baptist Church.

The Fort Morgan Planning and Zoning Advisory Committee will post on our website **[www.fortmorgancivic.org]** re-zoning and variance request notices received from the county commission. Please refer other non-FMCA property owners who wish to stay up to date to our website.

Notices of rezoning requests are posted on the property involved and mailed to <u>adjacent</u> landowners by the County. FMCA also will send a special email to all members on our email list of the time and place of our Fort Morgan committee meeting and will post signs on Fort Morgan road near both fire stations. Our email notice to members is to let non-adjacent property owners who may be affected by the request express their concerns to our local committee before it submits a recommendation to the county. Any FMCA member who receives the Fort Morgan NEWS by U.S. Postal Service and wishes to receive these rezoning request notices will have to furnish us with an email address, to be sent to Chan West at: <u>chan@goefish.com</u> We encourage property owners with vested interests to bring their concerns and comments to these meetings. In most cases these notices are received about 10 days before the county Planning and Zoning Commission or Board of Adjustments meeting.

Turtle Tracks 2017~~~~~~~ Total Fort Morgan = 84 Nests!!

More than 4,000 babies have been assisted to the Gulf water this season so far. We have five nests yet to hatch and expect all to be viable. The last next will reach day 55 on October 3rd. This year there was a rare leucistic hatchling which resembles an albino but has normal eyes. It was healthy and beautiful.

Final Reminders "For the Turtles"

[1] Turn Off Lights at dark that shine on, or can be seen from, the beach. "Turtle Lighting" is available from local home supply stores.

[2] Use Red Light Only on the beach at night, not LED or white light. LED lights blind not only the turtles, but the volunteers, too!

[3] Fill in Holes dug in the sand when leaving the beach for the day. Some huge holes have resulted in turtles being stuck and unable to lay their nests.

[4] **Remove Items** from the beach when leaving each day to prevent turtles from becoming entangled and stranded.

Monarch Walks on 2 Fridays: October 27th and November 3rd, both at 9:00am.

Have you ever wanted to learn more about the magnificent migration of the monarch butterfly and their fascinating life cycle? Come join Refuge volunteer, Homer Singleton, as he leads participants along the Gator Lake Trail searching for this beautiful butterfly. During the walk Homer will introduce you to the butterflies which pass through this area, their habitats and their life cycles. Participants will also be asked to help catch monarch butterflies so that they can receive tags that will allow scientists to track their migration. Walks begin at Gator Lake trailhead off of Mobile Street. Walks typically last anywhere from 2.5-3 hours and participants should come prepared to walk over 2 miles, in the soft sand, with minimal shade. Water and bug spray are highly suggested. Jeff Friend Trail Update ~ Trail is closed for improvements (ADA accessibility and improvements to the boardwalk), until Spring 2018. Pine Beach Trail, Gator Lake Trail, and Centennial Trail will remain open. The Kayak Launch at Jeff Friend Trail will remain open but with extremely limited parking. We look forward to everyone enjoying the completed renovations!



In mid-October Dr. Greg Waselkov, USA Archaeology Department Chair, Harry King and several volunteers will begin an excavation of the Indian Canal. At the site earlier this year, material for carbon-14 dating was obtained and subsequently verified by a professional lab in Florida. Results were much older than anticipated. The material was carbon-14 dated to approximately 566 A.D.-or 1450 B.P. [1,450 years ago]. Local Native Americans were engineering and completing a major public works project, hand digging a trade canal one mile through the pine forest on Fort Morgan Peninsula. This canal would open a route south into Florida and provide trade for copper from Michigan, obsidian from Wyoming, mica from North



Carolina, ocher from Alabama and salt from Texas.

This native socio-economic population was thriving in the Fort Morgan and Bon Secour, Alabama area 1400 to 1500 years ago.

EARLY ROADS INTO BALDWIN, SETTLEMENT OF PLASH ISLAND, WPA BEGINS FORT MORGAN ROAD Originally foot paths were the only way to travel in the early history of Baldwin County. Later settlers widened the paths by wagons and buggies. Three-trail roads were followed and later settlers began cutting down trees, lashing them together with vines. That of course was until they hit the bogs, creeks, and sand of the coastal area. Before the cut of the intracoastal waterway, land all the way to the Gulf Coast was swamp, marsh, wetlands or beach.



In 1839 upper Baldwin had a stagecoach line cutting from Mobile up to Montgomery. This became a mail route and the cost of a letter, seventy-five cents. In 1917 settlers used boats to get to Plash Island. Sandy roads connected the villages of Shell Banks and Gasque to Fort Morgan.

The original Fort Morgan Road was built by transient labor under the Works Progress Act (WPA), a program of President Roosevelt's economic recovery plan. The men were housed, fed, and given small pay. The work was begun by the Civilian Conservation Corps (CCC) in 1934 and was completed by the WPA in 1936. Dedicated during Governor Bibb Graves' term, the road was opened to the public and named Dixie Graves Parkway after the governor's wife.





One of the most unusual things about the road is that there is a 330 foot right-of-way. For the CCC and WPA to do the work it had to be a state-owned parkway with a minimum right-of-way width of 330 feet. It was a scenic drive all the way to Mobile Point. Sadly, just as the road was being completed two men were killed—a native of Richmond, Virginia and another from New York. One can see that Fort Morgan community is a place of history.
