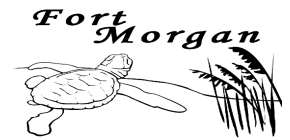

David Whetstone gave his overview of a "preservation" association to broaden the support base to advocate rational development, protect the environment, and preserve the historical significance of our portion of the island. Establishment of the "Friends of Fort Morgan" program seemed acceptable to many in attendance. Fort Morgan Planning & Zoning Committee ~~~~~Chan West, Chair

A semi-annual meeting of the Fort Morgan Planning and Zoning Advisory Committee was held on October 17. Vince Jackson, head of the county Planning and Zoning, presented a draft of an amendment to county regulations concerning Dune Walkovers in District 25. Highlights are:

- ~ No more than six feet in width for multiple family/commercial/public structures and four feet in width for single/two family structures
- ~ Without roof or walls
- ~ Elevated at least one foot above dune and no more than three
- ~ Shall begin at the existing ground level elevation of the principal landward structure
- ~ Shall terminate no more than ten feet seaward of the vegetative line of the dune

Additions concerning materials, plumbing, electricity, etc., are being considered. Comments were favorable.

Two rezoning requests were considered and both were recommended for denial. They are on the agenda for the county Planning and Zoning Commission meeting Thursday, November 1, 2018, in Robertsdale.

~ Z-18051: Willis property at 13790 Old Fort Morgan Road.

Request to rezone 1.39 acres (2 lots) from RSF-1 to RSF-4 to allow family subdivision of the property into four lots. Our committee considered that this division could be accomplished at RSF-2 or RSF-3.

~ Z-18952: Marina Holdings We LLC Property at 1577 Hwy. 180

Request to re-zone 4.1 acres from B-2 to B-4 to allow use as a marina. This is the parcel adjacent to the Marina on the west side. The LLC owns both parcels and a sale is contingent upon this re-zoning. They state that it was once zoned B-4, but failed to present evidence of that. This is the basis for our committee's recommendation of denial.

Fort Morgan History **Alabama Gulf Coast 1933-1939**

We will continue to explore the history of the CCC, WPA, and paving of the Fort Morgan Road through newspaper articles which Heather Tassin, Fort Morgan director, and Jeanette Bornhold, Foley Library, have so graciously provided. The following is from The Montgomery Advertiser, December 19, 1933.

Historic Old Fort Morgan To Offer Transients Home **Government "Hobo Camp" Proposed for Site of C. S. A. Stronghold**

Historic old Fort Morgan, abandoned by the government more than 18 years ago and with adequate buildings accommodations for 2,000 persons, will soon be transformed into a government hobo camp, if projected plans of the Alabama Relief Administration materialize. Under the tentative outline, the camp would be operated on a plan similar to that of the Civilian Conservation Corps.

The old fort, inhabited only by a caretaker and a radio operator, is on the Gulf of Mexico. It has one of the finest natural beaches for surf bathing and fishing. It is equipped with adequate docks for boats, and, according to Commander I. T. Quinn, it is surrounded by the finest fishing waters in the world – when fish are biting. It is about 14 miles below Foley, the nearest railroad point.

The prospect of using this gigantic outpost as a sort of reclamation center for tramps or "transients" with a formal offer of the old fort to the Federal Relief Administration about a month ago.

The Federal Relief Administration in turn offered the fort to the Alabama Transient Bureau, a unit of the Alabama Relief Administration. A representative of the Alabama Transient Bureau recently visited the old Fort and made a favorable report on the proposal. Washington, in turn, has been notified that the Alabama Transient Bureau is favorably impressed with the offer.

Definite action on the matter, however, has been withheld pending recovery of W. J. Plunkert, director of the Alabama Transient Bureau, who was slightly injured in an accident a few days ago, according to Thad Holt, director of the Alabama Relief Administration.

The plans for the operation of the camp have not been made, Mr. Holt said. They will probably embody the repairing of buildings and the construction of a road to connect with the State Highway that extends from Foley to the Gulf. The young men will also probably be given health and other forms of training.

It is probable, Mr. Holt said, that the camp will be opened only to young transients, the Government to pay transportation expenses from any of the key centers in Alabama, and to provide them with adequate food and clothing. Whether or not they will be paid as CCC workers are paid is a matter also to be decided.

In several of the larger cities in Alabama the Government is now operating transient bureaus, wherein a transient may register and receive a bed for the night. These bureaus, it is proposed, will be enrollment headquarters for the Fort Morgan encampment. The period in which the camp will be operated is indefinite.

The young men to be quartered there would also be given an opportunity of "brushing up" on their history, as the site of one of the great naval battles of the War Between the States is but a few hundred yards off Fort Morgan. It was at this point that Admiral Farragut with a small fleet broke the chain that had been stretched from Fort Morgan to Fort Gaines, about a mile distant, and engaged in combat with the iron-clad Confederate boat "Tennessee," and other small Confederate boats, which were guarding the Mobile channel.

During the battle the Tennessee was sunk about 500 yards off the northwest bank of Fort Morgan, and Farragut was victorious. The Confederate forces also succeeded in sinking the Federal paymaster's ship a few hundred feet from the mainland. The ship, according to tradition, had about \$350,000 in the hold and the money was never recovered. It is now buried, according to old "salts" in the section, about 30 feet or more under the sand at the Gulf's edge.

The Confederate forces maintained that Farragut was victorious because the Tennessee's rudder was smashed early during the battle and she was unable to maneuver. Other reports have it that a shot from Fort Morgan, intended for Farragut's boat, struck and sank the Tennessee instead.

An interesting story of the various inhabitants of the Fort since its abandonment is told by Capt. Harry Hargrove, president of the Mobile Bar Pilot's Association.

Capt. Hargrove, it should be reported, is also a fisherman.

At the time the Fort was abandoned, Capt. Hargrove said, one of the officers left there several rabbits he had been raising as a hobby. As time passed the rabbits multiplied rapidly. Soon the Fort was given the name of

“Rabbitville” by the pilots who passed daily through the channel. It was not unusual, Capt. Hargrove related, to see scores of rabbits frolicking along the beach around the old Fort.

This lasted until one day the rattlesnakes grew wise to the bounteous feast that awaited them at the old Fort. As the snakes increased, the rabbits decreased. They became a menace to the caretaker who made his daily rounds with extreme care. The caretaker was at a loss to know what to do.

Then one day the caretaker purchased several pigs and gave them range of the Fort. To his surprise the snakes began to disappear. Whether the pigs ate the snakes, or the snakes fled because of fear of the sharp hoofs is a mystery that has never been cleared.

Anyway, according to Capt. Hargrove, the caretaker and his wife eventually ate the pigs and all has been serene since that day.

From the By-laws Adopted April 11, 2005

ARTICLE III – MEMBERSHIP

- Section 1 Regular (voting) Membership in this association shall be open only to property owners and/or residents in the unincorporated area west of mile 14.7 of the Fort Morgan peninsula.
- Section 2 Associate (non-voting) Membership shall be open to residents of areas outside the Fort Morgan Peninsula whose interests coincide with those of the Association including the preservation of the environment and quality of life of the Fort Morgan peninsula.
- Section 3 Membership application shall be made by completion of a form provided by the Association and payment of the required dues. Dues for the following year shall be determined at the October general meeting and shall be for the following calendar year January 1st through December 31st.
- Section 4 Payment of Regular (voting) Membership dues entitles a member household to one (1) vote. A member household is comprised of Association members living at one physical address. Past year member households paying dues after January 31st and new members joining the Association will have no voting rights until thirty (30) days after payment of dues.
- Section 5 Payment of Associate (non-voting) Membership dues entitles the member to attend all member meetings and receive the monthly newsletter.
